

How to Download Previously Submitted Reports

Overview of Annual Progress Report

- The completion and submission of an annual report are mandatory for all projects as a condition of ethical approval and governance authorisation.
- The annual report is due 1 May annually.
- Failure to submit a satisfactory annual report will result in the withdrawal of HREC approval and/or Governance authorisation, which leads to study suspension. Consequently, all study activities must be halted until the approval is granted.
