Occupational Therapy A guide for lower limb amputees



Occupational Therapists (OT) can help you return to your daily activities.

Your OT can help with:

- adjusting to your amputation so that you can actively participate in day-to-day life
- sourcing equipment and wheelchairs
- assessing your home and work environments
- returning to community and leisure activities.

Some of this will be completed while you are in rehabilitation while others are more appropriate once you are home.

Wheelchairs

A wheelchair is recommended following your amputation. Your Occupational Therapist will work with you to choose the right wheelchair for you. You will be able to try different wheelchairs.

You may also be able to receive equipment funding through the State Wide Equipment Program (SWEP). Your Occupational Therapist will assist you with this process.

There are often long wait lists for new equipment. You may need to hire a wheelchair to use while you wait. The cost of this hire will be your responsibility.

Second hand equipment can sometimes be provided to avoid the long waitlist.

If your wheelchair or scooter breaks down, RACV can assist with repairs. If it cannot be repaired, they can help you and your wheelchair get home safely.

Home modifications

Home modifications may be required before you return home.

A home assessment can be completed before you leave hospital if needed. All recommendations will be discussed with you. Common modifications include rails and ramps.

If there are ongoing needs once you leave hospital, you will be referred to your local community rehabilitation or health centre.

It is important to think about how you will manage at home if you cannot wear your prosthesis. SWEP funding is also available for home modifications; however waiting lists do apply.

Please note: SWEP and major modifications take a long time to be completed. They may not be done before you leave hospital. If needed you will be referred on to a community OT to finish the process.

Transport

Driving

You will need medical clearance before returning to drive.

Vic Roads are responsible for making sure people are safe to drive. They may need you to complete an OT Driving Assessment.

The OT Driving Assessment can include both a written and practical driving test.

Your OT Driving Assessor will make recommendations if changes are needed to your car to allow you to drive safely.

If your driving has not been assessed as safe and you drive and are involved in an accident your insurance company will not cover you.

Parking

You may be able to get a disabled parking permit if walking a long distance is hard for you.

Application forms can be found at your local council. Applications need to be completed by a doctor. Permits are recognised elsewhere in Australia, however parking conditions may differ between States and Territories and should be checked prior to travelling.

An OT can make recommendations to adapt your workplace/role to enable you to fulfil your work requirements.
