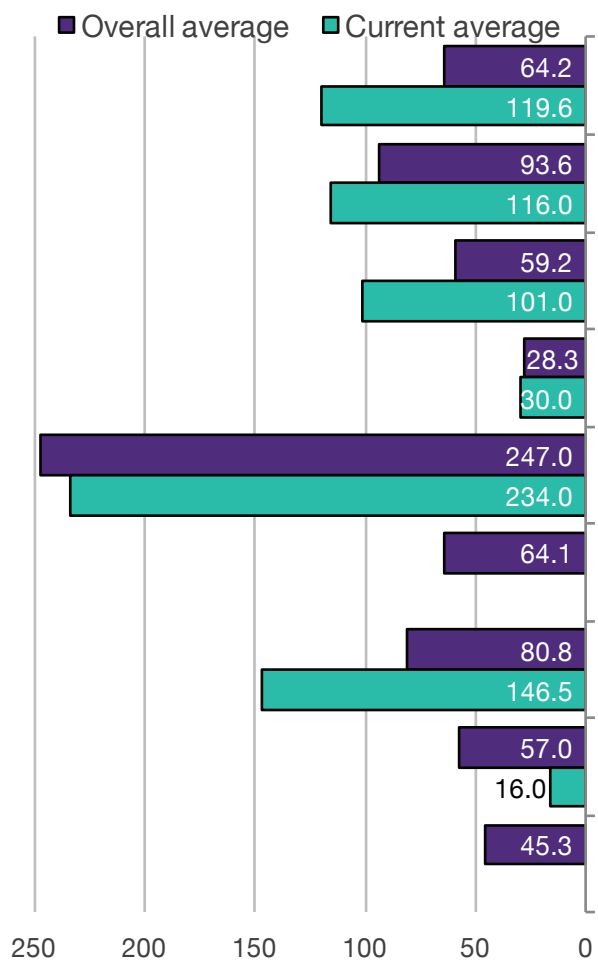

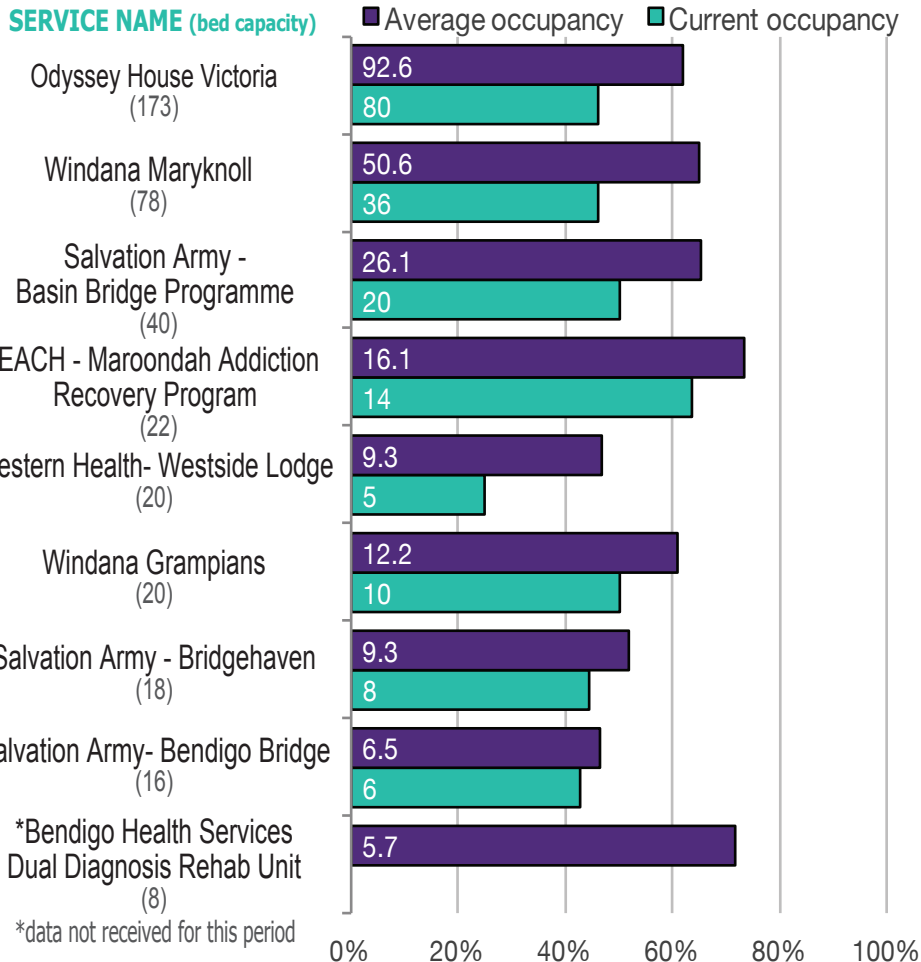

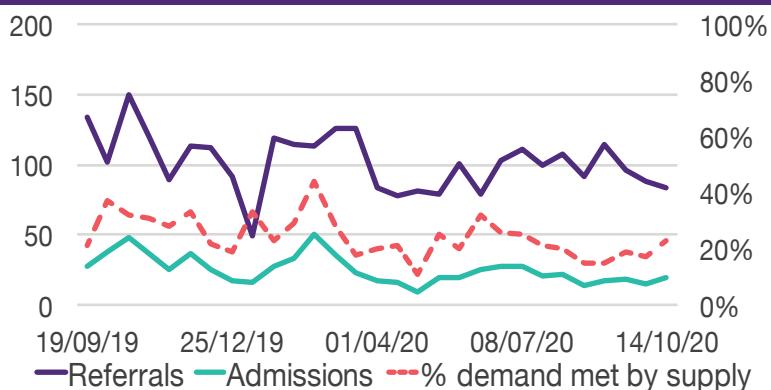
AV. DAYS B/W REFERRALS & ADMISSIONS



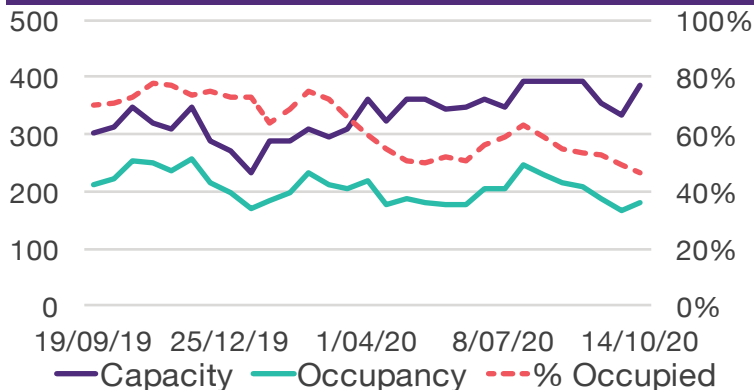
CURRENT & AVERAGE OCCUPANCY



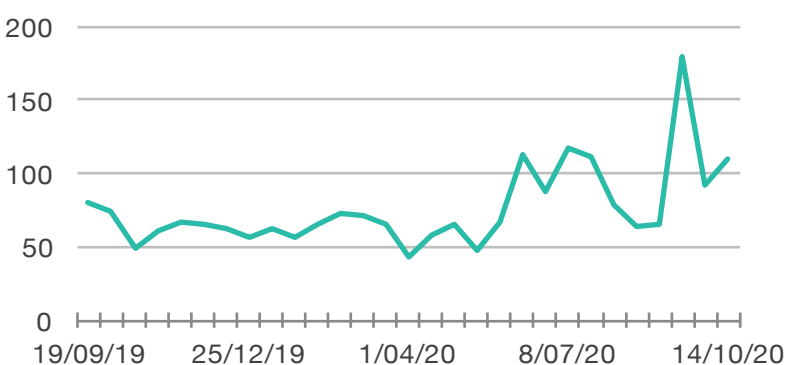
REFERRALS & ADMISSIONS



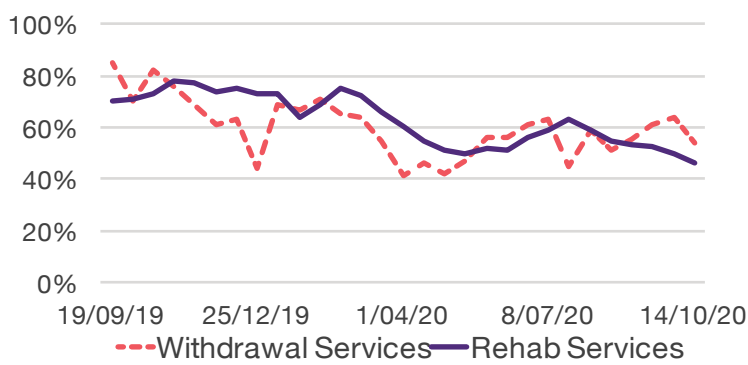
BED CAPACITY & OCCUPANCY

REPORTED ISSUES PERTAINING TO REFERRALS & ADMISSIONS

Windana Grampians - We remain at an 18-bed capacity and constrained by the reduced capacity of Withdrawal programs.

Bridgehaven- Client due to be admitted 21.10.2020. No leave or visitors. Program otherwise running as normal. Clients completing 10 day stay at Curran Place and being COVID tested twice prior to admission.

Basin Bridge -

- Beds still reduced
- Client's unable to have leave or visitors
- Isolation units available if a client has an external appointment must then be COVID tested and stay in isolation unit until results return.

Westside Lodge - Full capacity is 20 beds. Currently operating at 50% with only 10 beds available due to COVID restrictions. All staff/clients wearing masks & social distancing.

Windana Maryknoll -

- Client must come direct from another service with all covid clearance required.
- No UDS straight from community.
- No visitors on site.
- Leave within the covid restrictions (local bush walks etc).
- 2 pods allocated for isolation if required.

Bendigo Bridge - Reduced capacity due to capital works commencing in December. Beds will be available in February. Currently working towards metro clients being admitted post lockdown.

EACH - Health screening.

Odyssey House - information re COVID restrictions Admission into a detox where COVID tests are being completed is preferable. Clients on admissions are informed if there is any residents at the TC being tested for COVID, they can then make a choice around proceeding with admission or delaying. Unable to proceed with admission if an individual has symptoms, or has been in contact with someone being tested/or testing positive. In this situation we will require a period of quarantine and negative test results. (follow direction from COVID hotline) COVID screening with client prior to admission, transport to be provided by approved health professionals or taxi, if coming from custody is preferred for the prisoner transport service to transport them. Temp checks and COVID screen completed on admission. No community withdrawals, admissions from detox or custody only. Now admitting from all suburbs of Melbourne, however not from Melbourne to our Rural Facilities. All staff to wear masks, optional for residents while at the TC (considered their home), residents wear masks when leaving TC. Staff wearing shields as well as masks when in contact with clients. Complying with COVID Care Facility Directions from Government. No visits or leave with the exception of special circumstances.

Odyssey Lower Plenty: : Approx. 2-3 months for singles, and couples. Family admissions - we have family rooms available, however 2 family admissions this week (for parents with children in their care) Current maximum is 80 beds.

HOPE: Have put a hold on clients seeking admission from Melbourne to HOPE, these clients given the option of Lower Plenty site. Approximately 5 female beds available, and 4 males beds for rural clients in the area. Please note this is once the assessment process has been completed. However four male admissions scheduled. Current maximum is 29 beds
