This document outlines the mandatory training requirements for those working as Graduate Registered and Enrolled Nurses.

Recognition of **Prior Learning**

Have you completed training elsewhere? You may be eligible for Recognition of Prior Learning.

Check the RPL section at the back of this document.

How should I read this document?

This document details the training you must complete. Your Required Learning will be listed across three sections:

Orientation Learning is to be completed during your Orientation.

Onboarding Learning is to be completed during your first 12 weeks.

Ongoing Training is training to be completed on a repeating basis.

Please ensure you check each section carefully, including the Specific Learning.

How can I check my training history?

You can check your training history by searching for and running the "My Transcript" report in Workday.

You are able to print certificates for your training by searching for and running the "Print Learning Certificates" report in Workday. Leaving the Course section of this report blank will allow you to print all of your most recent training.

Move Smart Learning

Low Risk Staff and High Risk Staff have differing requirements for Move Smart.

If you do not complete Patient Manual Handling in your role, you are Low Risk and must complete:

SVHM Move Smart Training (Online)

If you do perform Patient Manual Handling, you are High Risk and must complete:

SVHM Move Smart Training - Refresher Training (Practical)

Basic Life Support

Basic Life Support at SVHM is made up of two components – an Online Learning Package and an in person Practical Assessment. To be deemed competent, you must recomplete these both at their required intervals.

The Practical Assessment must be completed on an annual basis with your local trainer.

SVHM Basic Life Support Practical (Completion Record)

The Online Learning Package must be completed every 5 years to remain competent.

Recognition of Prior Learning

If you have completed some of your Required Learning at an external health service, or at a Registered Training Organisation (RTO), you may be eligible for Recognition of Prior Learning (RPL).

You will need to ensure the RPL you are applying for is on the below list of approved courses for RPL, which details which Required Learning courses are eligible for an RPL application.

How to Apply

In order to apply for Recognition of Prior Learning, please complete the following steps.

- 1. Collect evidence of your training, typically in the form of training certificates.
- 2. Separate evidence for each RPL course you wish to apply for.
- 3. For each course you which you wish to apply, send an individual email to SVHM.Education.RequiredLearning@svha.org.au with the relevant certificate. Ensure that you state that you are applying for RPL, as well as the course you are applying for RPL for.

If accepted, your RPL will be valid from the date your training was initially conducted. For example, a Hand Hygiene application for learning completed 01/01/2023, would provide you with SVHM competency until 01/01/2024.
